# 6. Superintendent's Report

### a. Vacancies, nominations, recommendations

Superintendent Moody reviewed vacancies and recommended the Board's approval of nominations.

### b. Report on Assessments Payments to Date

Superintendent Moody shared that as of August 22, 2024, Canaan, Cornville, Mercer, Norridgewock and Smithfield were current on their

monthly assessments. Skowhegan was outstanding for July and August. Assessments are due on the 20<sup>th</sup> of each month.

### c. Update on New School Construction Building Project

The Percent for Art Committee held their first meeting on August 15<sup>th</sup>. Superintendent Moody and Principal Myla Kreider joined committee members Sara Smith and Peggy Lovejoy, Architect Doug Breer as well as two artists from the community and rep from the Maine Arts Commission. The next committee meeting is scheduled for December 11<sup>th</sup> at 10:30 at the Superintendent's office.

Small group tours of the building site can be arranged for any interested board members; those interested should reach out to the Superintendent. Windows are scheduled to be delivered on 9/16/24, and installation will begin throughout the months of September and October.

Superintendent Moody shared that he was appointed as Superintendent Representative for the State on a Commission studying the State Board's role and duties and is specifically tasked with reviewing school construction and DOE certification.

### d. Review/Update of Federal Projects

Finance Director Melannie Keister continues to move through reimbursements and is closing in on the spending. The Superintendent will share an update on federal spending in the future.

The Department of Education hosted a community conversation at the high school tonight. The goal is to bring educators, parents, students and business leaders together to discuss a shared vision for our schools. The DOE has been holding these in person conversations throughout the state for the past two months.

# e. Select Representative to the Delegate Assembly

Samantha Delorie volunteered to be the Alternate Delegate Representative.

### f. Summer Work

Assistant Superintendent Hatch shared that over the summer administrators and staff participated in Literacy and Science Curriculum Work and Training. Administrators spent three days of intense training

on a new evaluation model, which focuses on improvement of instruction and how administrators give feedback and track growth with our staff and target areas for improvement.

### g. Start of School

Superintendent Moody shared that Opening Day for staff is set for Monday, August 26<sup>th</sup>, starting with breakfast at 7:15 in the high school cafeteria and followed by a districtwide welcome gathering for all staff. Board members are welcome to attend.

### h. Other

Current enrollment, as of 8/22/24, was 2,119.

## 7. Assistant Superintendent and Support Services Manager

Assistant Superintendent Hatch reported that hiring is going well and the district is close to being fully staffed. The district has hired long-term substitutes, including retired teachers, to fill several vacancies.

The Assistant Support Services Manager, Jessica Brown, reported that custodians are excited to get back to second shift following a busy summer working to clean and prepare the schools for the opening.

### 8. Old and Unfinished Business

Michelle Kelso shared ranking statistics for Maine in the 90's consistently ranked first or second on the national assessment of educational progress in math and reading and now we are down to 36<sup>th</sup> in the nation.

### 9. Introduction of New Business

Julian Payne extended his appreciation to all involved in the preparation and planning for the End of Summer Cookout for summer staff.
